



## **Spanish Speaker Roundtable**


- Conducted 09/27 in Spanish at Norcross library
- 6 Norcross residents invited
  - 3 people indicated availability
  - 1 mom and daughter participated
- Takeaways
  - Preserve: Norcross's trees, scale of development, quaintness, sense of safety
  - **Future growth preferences:** continued focus on single family homes, no large buildings, more parks space
  - **Needs:** safe spaces to ride bikes, closer medical services/24-hour assistance, more job opportunities, safer roads/driving conditions, stoplight/signal improvements (for non-car drivers)
- Discussed 10/19 Open House and provided promotions in Spanish for participants to share

- Most comments supportive
- Projects with least support:
  - T-18: Parking along Thrasher Street
  - T-15: Extended Wingo Street
- Mixed support for gateways (T-9)





- Dining options and parking downtown










Do you feel that the future of the property along Langford Drive is more similar to the neighborhood character that Hopewell Woods seeks?

- **30% no**



- 7% no






Do you think the area east of Summerour St and south of Buford Highway should be included in Character Area 9 (Summerour) to preserve the character of ongoing and upcoming development?

#### **Character Area Map Updates**

- Draft Character Area Map reflects changes based on feedback from the public.
- The proposed map reflects 12 character areas instead of 13.
- Vision of each character area will remain with minimal changes. Character areas 6 and 7 will be combined and reflect updated implementation strategies.



#### **Priority Needs & Opportunities**

- Maintain and enhance a sense of community, small-town feel, and level of community services as new development comes online.
- Ensure housing is available to all residents and newcomers with unique public amenities such as parks and family-friendly activities.
- Unite the community across cultural backgrounds and socio-economic status
- Address **transportation** needs and traffic congestion by
  - Improving walkability and the pedestrian infrastructure beyond Downtown,
  - Implementing trails and greenways, and
  - Supporting the expansion of MARTA rail to increase local and regional connectivity and attract commerce.
- Attract younger families and invest in our schools.
- Improve quality of life through sustainable practices
- Leverage technology and explore Smart City strategies.

- 1. Regularly evaluate the Unified Development Ordinance
- 2. Enhance and maintain the city's gateways

- 4. Support efforts to conserve and enhance the city's nature-based assets
- 5. Continue to program community events like the Community Market and Gateway Int'l Festival that celebrate the diverse and inclusive nature of the community
- 6. Implement recommendations of the Master Arts & Cultural Plan



## Goal 2

## Continue to strengthen Norcross as a livable, inclusive, and safe environment.

- 1. Encourage the expansion of the historic downtown commercial district
- 2. Be an active partner in the redevelopment of the Buford Hwy corridor
- 3. Participate in the Georgia Initiative for Community Housing (GICH)
- 4. Maintain Platinum Green Community Status
- 5. Continue to offer youth health, wellness, and storytelling programs through the Community Center



## Goal 3

Increase opportunities for travel via different modes within and outside the community

- 1. Invest in sidewalk and bicycle connectivity and safety
- 2. Work with regional partners to expand transit service
- Continue the development of a robust trail and greenway system with seamless connections to the county's greenway system, including the implementation of Beaver Ruin Creek Greenway
- 4. Enhance downtown parking through the application of Smart Technologies
- 5. Improve bus stops along Buford Hwy, Beaver Ruin Rd, and Norcross Tucker Rd



# **Goal 4** Maintain a vibrant economy and continue to facilitate job growth.

- 1. Business recruitment, retention, and expansion initiatives
- 2. Implement target industry study and strategic marketing plan
- 3. Enhance tourism through filming and visitor engagement initiatives
- 4. Develop market analysis tool to help identify and facilitate redevelopment opportunities
- 5. Facilitate entrepreneurship and small business start-ups
- 6. Attract unique restaurants and shops to diversify downtown businesses
- 7. Continue to administer the Downtown Merchants Incentive Loan Program



## Goal 5

Ensure that Norcross residents have a variety of attainable quality housing options.

- 1. Participate in and implement recommendations of the GICH/Live Norcross Initiative.
- 2. Develop a pilot program to provide grant-funded incentives for residents to improve energy efficiency and indoor air quality in their homes, and host property management classes to teach owners how to care for investments, improve safety, and improve property values.


#### **Key considerations for LCI transportation funding**

- Transportation funding is competitive with other LCI communities
- For the LCI pot of funds, ARC prioritizes projects in communities that have demonstrated commitment to implementing their LCI plans
- Next round of applications will likely start in the Spring of 2024, which funding available starting in 2025
- All projects should support the creation of Complete Streets and improve safety and incorporate proven safety countermeasures
- Equity is important so for example, a sidewalk or path that connects to lowincome housing, senior housing, or to transit, would score highly
- Local match of 20% (standard 80/20 split)
- Grant amounts for PE, ROW, UTL, and CST range between \$2 million and \$15 million, with the typical around \$5 million








